

Offer Terms and Conditions

 - a. the website www.amazon.in or the mobile site or mobile application thereof (collectively, "**Amazon.in**")
 - b. the website www.oneplus.in or the mobile site thereof (collectively, "**OnePlus.in**")
 - c. OnePlus Experience Stores, Authorized Stores, Kiosk and Mall Pop-ups (collectively, "**OnePlus Offline Stores**")
 - d. Croma, Reliance Digital, Top 10, Poojara, Sangeetha, Poorvika, Other Chain-store partners (collectively, "**Third Party Offline Stores**")
 - e. Amazon.in, OnePlus.in, OnePlus Offline Stores and Third Party Offline Stores would collectively be referred to as ("**OnePlus Channels**")
